RESOLUTION NO. 95-74

A RESOLUTION RESPECTFULLY REQUESTING THE REGIONAL
TECHNICAL DIRECTOR, LANDS MANAGEMENT SERVICE,
DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES, REGION
08, TACLOBAN CITY, TO FURNISH SOONEST THE SANGGUNIANG
PANLUNGSOD NG ORMOC OF THE REQUESTED TECHNICAL
DESCRIPTION OF THE BOUNDARIES OF THE MUNICIPALITY OF
KANANGA, LEYTE, AND THE CITY OF ORMOC, WITH THEIR
CORRESPONDING MAPS DULY CERTIFIED BY THE LANDS
MANAGEMENT SERVICE.

WHEREAS, there is a pending boundary dispute between the
Municipality of Kananga, Leyte, and the City of Ormoc;

WHEREAS, Article 17 of the Rules and Regulations Implementing the
Local Government Code of 1991, Governing the Procedures for Settling
Boundary Disputes, requires among others, the attachment to the petition
of: 1) City, Municipal Map, duly certified by the LMB; 2) Technical
description of the boundaries of the LGUs concerned;

WHEREAS, the aforementioned documents were long requested by this
Sanggunian from the Lands Management Service of the Department of
Environment and Natural Resources, Region 08, Tacloban City;

WHEREAS, the then Regional Technical Director Felipe S. Sison in
his letter of February 17, 1994, addressed to this Sanggunian informed
in part: "We may nevertheless be able to assist in the settlement of
the boundary conflict between your City and the Municipality of Kananga
by the end of April 1994 when by then on-going political boundary survey
of Kananga shall have been completed and submitted to the Office.";

WHEREAS, the Members of this Sanggunian are now very desirous that this long pending boundary dispute between the Municipality of Kananga, Leyte and the City of Ormoc be settled once and for all at the earliest time possible.

WHEREFORE, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Public Properties, severally seconded by mga Kagawad Benjamin B. Lladoc, Claudio P. Larrazabal, Alfredo F. Capahi and Jose C. Alfaro, Jr.; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution RESPECTFULLY REQUESTING THE REGIONAL TECHNICAL DIRECTOR, LANDS MANAGEMENT SERVICE, DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES, REGION 08, TACLOBAN CITY, TO FURNISH SOONEST THE SANGGUNIANANG PANLUNGSOD NG ORMOC OF THE REQUESTED TECHNICAL DESCRIPTION OF THE BOUNDARIES OF THE MUNICIPALITY OF KANANGA, LEYTE, AND THE CITY OF ORMOC, WITH THEIR CORRESPONDING MAPS DULY CERTIFIED BY THE LANDS MANAGEMENT SERVICE;


RESOLVED, FURTHER, to convey the sincerest thanks of this Sanggunian to the Regional Technical Director, Lands Management Service, Department of Environment and Natural Resources, Region 08, Tacloban City, in anticipation for his kind and prompt attention and action hereon;


