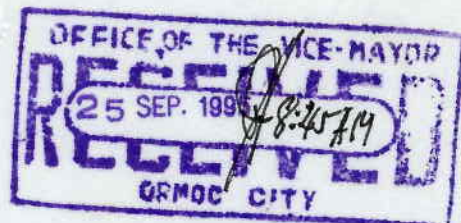

Despite the operations of Multicabs (PUJs) and existing tricycle units plying to and from Ormoc City, still we could observe the inadequacy of our available transportation to serve the riding public. As usual, our tricycle terminals and even city streets are always crowded with commuters especially during working days.

Considering the need for more transportation to serve our constituents, may I respectfully request for the passage of a resolution for an additional fifty (50) tricycle police numbers to augment our present number of tricycle units.


