RESOLUTION NO. 95-77

A RESOLUTION RETURNING TO THE SANGGUNIANG BARANGAY OF BARANGAY LABRADOR, THIS CITY, ITS ORDINANCE NO. 95-002 S. 1995 ENTITLED, "AN ORDINANCE PROHIBITING ASTRAY ANIMALS, SUCH AS PIGS, GOATS, CARABAOS, COWS, HORSES, ETC. FROM ROAMING AROUND THE BARANGAY STREETS, PLAZA, SCHOOL PREMISES, AND OTHER PUBLIC AND PRIVATE PLACES, PROVIDING PENALTIES IN VIOLATION THEREOF", WITH THE REQUEST THAT SECTION 2 THEREOF BE CLARIFIED.

WHEREAS, this august Body is in receipt of Ordinance No. 95-002 S. 1995 of the Sangguniang Barangay of Barangay Labrador, this city, entitled, "AN ORDINANCE PROHIBITING ASTRAY ANIMALS, SUCH AS PIGS, GOATS, CARABAOS, COWS, HORSES, ETC. FROM ROAMING AROUND THE BARANGAY STREETS, PLAZA, SCHOOL PREMISES, AND OTHER PUBLIC AND PRIVATE PLACES, PROVIDING PENALTIES IN VIOLATION THEREOF";

WHEREAS, this sanggunian, in relation to the aforecited ordinance at issue (and all other Ordinances of the Sangguniang Barangay in Ormoc City) is, by law, granted with the power to review on whether the said ordinance is consistent with law and city X X X ordinances, (Sec. 57 LGC 1991);

WHEREAS, the Seventh Sangguniang Panlungsod ng Ormoc, through the representation of the Honorable Chairman, Committee on Laws and Ordinances, has opted to return the said ordinance to the Barangay of Origin considering that Sec. 1 thereof made mention of Turkeys which are fowls making said ordinance unreasonable, thereby requesting that Sec. 1 thereof be clarified;

NOW, THEREFORE, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Laws and Ordinances duly seconded by Kagawad Gregorio A. Yrastorza, Jr.; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to return to the Sangguniang Barangay of Barangay Labrador, this city, their Ordinance No. 95-002 s. 1995 entitled, "An Ordinance prohibiting astray animals, such as pigs, goats, carabaos, cows, horses, etc. from roaming around the barangay streets, plaza, school premises, and other public and private places, providing penalties in violation thereof", with the request that Section 2 thereof be clarified;
