RESOLUTION NO. 95-78

A RESOLUTION RETURNING TO THE SANGGUNIANG BARANGAY OF BARANGAY CAMP DOWNES, THIS CITY, ITS RESOLUTION NO. 11 S. 1995 ENTITLED, "A RESOLUTION EARNESTLY REQUESTING THE SANGGUNIANG PANLUNGSOD (SIC) NG ORMOC FOR THE APPROVAL OF THE RESOLUTION REQUIRING THE COMPLIANCE TO FILE A FILING FEE WHEN HE/SHE MAKES HIS/HER COMPLAINT TO THE PUNONG BARANGAY PURSUANT TO PARA (A) SEC. 410, LOCAL GOVERNMENT CODE OF 1991 (RA 7160)", WITH THE RECOMMENDATION THAT THE SAME BE CONVERTED INTO AN ORDINANCE, AND THAT THE REQUIRED PUBLIC HEARING IN THE PASSAGE OF ORDINANCES LEVYING TAXES, FEES OR CHARGES SHOULD FIRST BE CONDUCTED, (SEE SECTION 274, RRILGC).

WHEREAS, this august Body is in receipt from the Sangguniang Barangay of Barangay Camp Downes, this city, its Resolution No. 11 s. 1995 entitled, "A Resolution earnestly requesting the Sangguniang Panlungsod ng Ormoc for the approval of the resolution requiring the compliance to file a Filing Fee when he/she makes his/her complaint to the Punong Barangay pursuant to Para (a) Sec. 410, Local Government Code of 1991 (RA 7160)";

WHEREAS, the Honorable MEMBERS of the SANGGUNIANG PANLUNGSOD, in SESSION, through the representation of the Honorable Chairman, Committee on Laws & Ordinances, has opted on returning the aforesaid resolution to the Barangay of Origin with recommendation on changing said resolution to an ordinance on levying of barangay fees or charges, and with the required public hearing pursuant to the provision of law;

WHEREFORE, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Laws & Ordinances, jointly seconded by mga Kagawad Sotero M. Pepito and Benjamin B. Lladoc; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to return to the Sangguniang Barangay of Barangay Camp Downes, this city, its Resolution No. 11 s. 1995 entitled, " A Resolution earnestly requesting the Sangguniang Panglungsod (SIC) ng Ormoc for the approval of the Resolution requiring the compliance to file a filing fee when he/she makes his/her complaint to the Punong Barangay pursuant to para (A) Sec. 410, Local Government Code of 1991 (RA 7160)", with the recommendation that the same be converted into an ordinance, and that the required public hearing in the passage of ordinances levying taxes, fees or charges should first be conducted. (See Section 274, RRILGC);

RESOLVED, FURTHER, to furnish copies of this resolution each to His Honor, the City Mayor; the City Administrator, the City Treasurer, the DILG-ACGO Officer and the Barangay Chairman of Brgy. Camp Downes, -all in Ormoc City;
