Committee on Finance, duly seconded by Kagawad Benjamin B. Lladoc; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution approving

ENACTED, October 5, 1995.



RESOLVED, FURTHER, to furnish copies of this resolution each to His
