A RESOLUTION RETURNING TO THE SANGGUNIANG BARANGAY OF CAMP DOWNES, THIS CITY, ITS UNNUMBERED ON THE CONTROL OF THE CONTR TROW 10:00 O'CLUCK TO 4:00 O'CLOCK IN THE TO CHILDREN WHO ARE SEVENTEEN (17) YEARS OLD AND BELOW" WITH THE RECOMMENDATIONS THAT CERTAIN MEREIN BE CLARIFIED AND PROVISIONS ACCORDINGLY AS INDICATED HEREUNDER.

WHEREAS, submitted to this Sanggunian for review is the Unnumbered Ordinance of the Sangguniang Barangay of Barangay Camp Downes, this City, entitled, "AN ORDINANCE IMPOSING 'CURFEW HOURS' FROM 10:00 O'CLOCK TO 4:00 D'CLOCK IN THE MORNING TO CHILDREN WHO ARE SEVENTEEN (17) YEARS OLD AND BELOW";

WHEREAS, perusal of the text of the aforecited ordinance showed that there are certain provisions which require clarification and amendment;

WHEREFORE, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Laws and Ordinances, jointly seconded by mga Kagawad Fernando P. Parrilla and Gregorio A. Yrastorza, Jr., be it

RESOLVED. AS IT IS HEREBY RESOLVED, to return to the Sangguniang Barangay of Barangay Camp Downes, this City, its Unnumbered Ordinance entitled, "An Ordinance imposing 'Curfew Hours' from 10:00 o'clock to 4:00 o'clock in the morning to children who are seventeen (17) years old and below", with the recommendations that certain provisions therein be clarified and amended accordingly, as indicated hereunder, to wit:

- Section 2 thereof, be clarified as to whether or not a 1. person considered minors if escorted by a person who is not his relative although responsible, is still liable under the proposed Ordinance;
- Section 4 thereof, be clarified as to the meaning of "LOITERING AIMLESSLY";
- Section 5 thereof, should likewise be clarified. What is meant by "PROPER DISPOSITION". In short, what action should the Punong Barangay take when a minor who is apprehended is now turned over to him.
- the penalty of ₹100.00 not quite EXCESSIVE considering that it is the minor violator who is required to pay the fine. It is suggested that the penalty be graduated. Perhaps for the first offense, a REPRIMAND is to be imposed.

ENACTED, October 5, 1995.

RESOLVED, FURTHER, to furnish copies of this resolution, one each, to His Honor, the City Mayor; the City Administrator, the President of the ABC, the DILG-ACLGO Officer, and the Sanggusiang Barangay of Brgy. Camp Downes through the Punosq Barangay, -all in Ormoc City;
