RESOLUTION NO. 95-87

A RESOLUTION REQUESTING THE HONORABLE CITY MAYOR FOR THE REPAIR AND RESTORATION OF BRIDGE PUENTE DE LA REINA TO PUT IT BACK TO ITS ORIGINAL BEAUTY AND HISTORIC SIGNIFICANCE AS A HERITAGE OF THE ORMOCANONS.

WHEREAS, a request was made by the Philippine Centennial Commission for an inventory of historical shrines and landmarks in the Local Government Units;

WHEREAS, the same request was reiterated by the DILG Acting Secretary Alexander P. Aguirre in an unnumbered memorandum, dated April 20, 1994, requesting all Governors, City Mayors, Municipal Mayors and DILG Officers for a complete list of the various shrines and historical landmarks in their respective areas; and to state their physical condition and whether there is a need to restore or repair them;

WHEREAS, in an answer to the abovementioned memorandum, Mr. Rodulfo A. Torcende of the DILG identified only one (1) historical landmark in the City of Ormoc, namely, the PUENTE DE LA REINA, constructed sometime in the year 1864, located near the Executive Building of Ormoc City;

WHEREAS, based on the findings of Engr. Rosita Cabaña of the City Engineer's Office, a recommendation was made for the repair and restoration of the bridge PUENTE DE LA REINA, and to quote:

"This landmark needs major repair in the sense that this bridge can only hold weight or not more than three (3) tons as evaluated by Engr. Rosita Cabaña of the City Engineer's Office. Being in the heart of the City's thoroughfare, it is believed that its repair and restoration work (including inscriptions) will not only make the bridge passable to heavy conveyances but

it would put back beauty and historical significance to a heritage of the Ormocanons."

WHEREAS, the preservation of this one and only identified historical landmark will enhance the cultural and historical background of the City of Ormoc;

NOW, THEREFORE, on motion of Kagawad Manuel T. Fiel, Chairman, Committee on Zoning & Beautification, severally seconded by mga Kagawad Gregorio A. Yrastorza, Jr., Claudio P. Larrazabal and Alfredo F. Capahi; be it

RESOLVED, to pass a resolution REQUESTING THE HONORABLE CITY MAYOR FOR THE REPAIR AND RESTORATION OF BRIDGE PUENTE DE LA REINA TO PUT IT BACK TO ITS ORIGINAL BEAUTY AND HISTORIC SIGNIFICANCE AS A HERITAGE OF THE ORMOCANONS;

ENACTED, October 5, 1995.

RESOLVED, FURTHER, that a copy of this resolution be furnished to the Honorable City Mayor Eufrocino M. Codilla, Sr.; Engr. Ruben C. Penserga, City Engineer; Mr. Rodolfo R. Torcende, DILG-ACLG Officer, and others concerned, -all in Ormoc City;
