A RESOLUTION REORGANIZING THE MEMBERSHIP OF THE COMMITTEE ACCREDITATION OF COMMUNITY BASED PEOPLE'S OKGANIZATIONS (POS), AGDs, INCLUDING BUSINESS AND PROFESSIONAL GROUPS AND OTHER SIMILAR AGRUPATIONS FOR MEMBASHIP IN THE LOCAL SPECIAL BODIES AS PROVIDED FOR IN ARTICLE 64 OF THE RULES AND REGULATIONS IMPLEMENTING THE LOCAL SOVERNMENT CODE OF 1991.

LAUs are mandated by law on promoting the establishment operation of People's Organizations (POs), NGOs, and the private to make them active partners in the pursuit of local autonomy; their membership to the Local Special Bodies in government is encouraged through accreditation, for them to be directly involved in the Plans, programs and activities of the LGUs, (Article 62 RRILGC);

WHEREAS, to this effect, the 6th Sangguniang Panlungsod had created the Committee on Accreditation charged in the screening and evaluation of papers or documents submitted by these NGOs or private organizations preparatory to the granting of accreditation pursuant to the provisions of the Local Government Code;

WHEREAS, lately, however, this august Body has opted to reorganize the Membership of its Committee on Accreditation for purposes of revising and/or increasing the number of membership thereof;

NOW, THEREFORE, foregoing premises considered on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Laws & Ordinances, jointly seconded by mga Kagawad Gregorio A. Yrastorza, Jr. and Alfredo F. Capahi; be it
