We would like to request for a change in nomenclature
for the position of City Secretary to Secretary to the
Sangguniang Panlungsod as provided in Section 325-f of the
Local Government Code of 1991 and Section 2.7 of the Civil
Service Memorandum Circular No. 19 s. 1992.

This Change in nomenclature was included in the
approved Organization Structure pursuant to Section 76 of
Republic Act No. 7160 and embodied in Sangguniang Panlungsod

Resolution No. 142 Ordinance No. 46 dated August 25, 1994, but not in the Personnel Schedule for Budget Year 1995 since the position was still occupied by the former incumbent.

For purposes of aligning the position title in the Personnel Schedule based on the approved Organizational Structure, we earnestly request for a change in nomenclature from City Secretary to Secretary to the Sangguniang Panlungsod.
