RESOLUTION NO. 95-94

A RESOLUTION TO RETURN TO THE SANGGUNIANG BARANGAY OF BARANGAY KADAOHAN THEIR ORDINANCE NO. 4 S. 1995, ENTITLED "AN ORDINANCE TO ENFORCE CLEANLINESS/HYGIENE WITHIN PIGPENS/PIGGERIES AND ITS PREMISES IN RESIDENTIAL AREAS OF BARANGAY KADAOHAN, ORMOC CITY" WITH THE RECOMMENDATION THAT THE SAME BE PROPERLY AMENDED AS NOTED HEREUNDER TO WIT:

1. SECTION 3 THEREOF, PAR. (3) - MAKE 4/5 THE MAXIMUM VOLUME WHEN THE EXCAVATION OF HOLES WILL BE COVERED; (b) MAKE TWICE THE MINIMUM FOR THE WEEKLY REGULAR WASHING OF PIGPEN.
2. SECTION 4, BARANGAY COUNCILS CANNOT IMPOSE THE PENALTY OF IMPRISONMENT. (SEE ART. 101 PAR. (a) (14))
3. ACCOMPANY YOUR ORDINANCE WITH A SELF-EXPLANATORY NOTE CONTAINING THE JUSTIFICATION FOR ITS APPROVAL. (SEE ART. 107 PAR. (b))

WHEREAS, this august Body is in receipt of Ordinance No. 4 of the Barangay Council of Kadaohan, this city, entitled "AN ORDINANCE TO ENFORCE CLEANLINESS/HYGIENE WITHIN PIGPENS/PIGGERIES AND ITS PREMISES IN RESIDENTIAL AREAS OF BARANGAY KADAOHAN, ORMOC CITY"

WHEREAS, this sanggunian, in relation to the aforecited ordinance at issue (and all other ordinances of the Sangguniang Barangay in Ormoc City) is, by law granted with the power to review on whether the said ordinance is consistent with law and city X X X ordinances. (Sec. 57 LGC 1991);

WHEREAS, the Seventh Sangguniang Panlungsod ng Ormoc through the representation of the Honorable Chairman, Committee on Laws and Ordinances, opted to return said Ordinance to the Barangay of Origin for the following reasons:

1. Section 3 thereof, Par. (3) - make 4/5 the maximum volume when the excavation of holes will be covered; (b) make twice the minimum for the weekly regular washing of pigpen.
2. Section 4, barangay councils cannot impose the penalty of imprisonment. (See Art. 101 Par. (a) (14))
3. Accompany your Ordinance with a self-explanatory note containing the justifications for its approval. (See Art. 107 Par. (b))

NOW, THEREFORE, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Laws and Ordinances, jointly seconded by Kagawad Alfredo F. Capahi and Benjamin B. Lladoc; be it

RESOLVED, to pass a RESOLUTION TO RETURN TO THE SANGGUNIANG BARANGAY OF BARANGAY KADAQHAN THEIR ORDINANCE NO. 4 S. 1995, ENTITLED, "AN ORDINANCE TO ENFORCE CLEANLINESS/HYGIENE WITHIN PIGPENS/PIGGERIES AND ITS PREMISES IN RESIDENTIAL AREAS OF BARANGAY KADAQHAN, ORMOC CITY" WITH THE RECOMMENDATION THAT THE SAME BE PROPERLY AMENDED AS NOTED HEREUNDER TO WIT:





CARRIED UNANIMOUSLY.


