RESOLUTION NO. 95-95

A RESOLUTION RETURNING TO THE SANGGUNIANG BARANGAY OF
BRGY. PATAG, ORMOC CITY, ITS ORDINANCE NO. 95-002,
ENTITLED, "AN ORDINANCE PROHIBITING ASTRAY ANIMALS,
SUCH AS PIGS, GOATS, CARABAOS, COWS, HORSES, ETC., FROM
ROAMING AROUND THE BARANGAY PLAZA, SCHOOL PREMISES, AND
OTHER PUBLIC AND PRIVATE PLACES, PROVIDING PENALTIES IN
VIOLATION THEREOF", WITH RECOMMENDATION THAT SECTION 1
THEREOF BE CLARIFIED AS TO WHAT "ETC" INCLUDES.

WHEREAS, this Sangguniang is in receipt of Ordinance No. 95-002
from the Sangguniang Barangay of Brgy. Patag, this city, entitled, "An
Ordinance prohibiting astray animals, such as pigs, goats, carabaos,
cows, horses, etc., from roaming around the barangay plaza, school
premises, and other public and private places, providing penalties in
violation thereof";

school premises, and other public and private places, providing
penalties in violating thereof", with recommendation that Section 1
thereof be clarified as to what "etc" includes;
