## RESELUTION NO. 95-95

A RESOLUTION RETURNING TO THE SANGGUNIANG BARANGAY OF BEGY. PATAG. ORNOC CITY, ITS ORDINANCE NO. 95-002, ENTINEEN. "AN ORDINANCE PROHIBITING ASTRAY ANIMALS, QUCH AS PIGG, GRATS, CARABAOS, COWS, HORSES, ETC., FROM ROAMING AROUND THE BARANGAY PLAZA, SCHOOL PREMISES, AND OTHER POWLIS AND PRIVATE PLACES, PROVIDING PENALTIES IN TISLATION THEREOF", WITH RECOMMENDATION THAT SECTION 1 THEREOF BE CLARIFIED AS TO WHAT "ETC" INCLUDES.

WHEREAS, this Sangguniang is in receipt of Ordinance No. 95-002 from the Sasaguniang Barangay of Brgy. Patag, this city, entitled, "An Ordinance prohibiting astray animals, such as pigs, goats, carabaos, cows, horses, etc., from roaming around the barangay plaza, school precises, and other public and private places, providing penalties in violation thereof":
