A RESOLUTION APPROVING ORDINANCE NO. 95-01 OF THE  
SANGGUNIANG BARANGAY OF BRGY. MAHAYAG, ORmoc CITY,  
ENTITLED, "AN ORDINANCE IMPOSING A CURFEW, TO ALL  
PERSONS, WITHIN THE JURISDICTION OF THIS BARANGAY, FROM  
11:00 O'CLOCK IN THE EVENING TO 4:00 O'CLOCK IN THE  
MORNING OF THE FOLLOWING DAY, PROVIDING PENALTIES AND  
EXCEPTIONS THEREOF.

WHEREAS, this august Body is in receipt of Ordinance No. 95-01 from  
the Barangay Council of Brgy. Mahayag, this city, entitled, "An  
Ordinance imposing a Curfew, to all persons, within the jurisdiction of  
this Barangay, from 11:00 o'clock in the evening to 4:00 o'clock in the  
morning of the following day, providing penalties and exceptions
