RESOLUTION NO. 25-10

A RESOLUTION RETURNING TO THE SANGGUNIANG BARANGAY OF BARANGAY SAN JUSA, THIS CITY, THEIR BARANGAY ORDINANCE 1995, ENTITUED, "BARANGAY TAXATION FOR THE SARI-SARI STORE, #20.00, BARANGAY CASE FILING FOR THE REASONS STATED HEREUNDER, TO WIT:

- STURES OR RETAILERS WITH FIXED BUSINESS ES MBLIGHMENT SHALL BE BASED ON THEIR GROSS SALES OR BEELPTS OF THE PRECEDING CALENDAR YEAR NOT TO YCEED #50,000.00 AT RATES NOT EXCEEDING HEREOF; AND NOT ON A FIXED AMOUNT AS PROVIDED FOR IN THIS ORDINANCE:
- THERE IS NO SHOWING THAT THE REQUIRED PUBLIC HEARING PRIOR TO THE PASSAGE OF A TAX ORDINANCE HAS BEEN COMPLIED WITH; SEC. ART. 274

IT IS SUGGESTED THAT YOUR TAX ORDINANCE COVERS THE TAXABLE ITEM PROVIDED FOR IN ARTICLE 240 OF THE RULES AND REGULATIONS IMPLEMENTING THE LOCAL GOVERNMENT CODE OF 1991.

WHEREAS, this august Body is in receipt of Ordinance No. 2 s. 1995 of the Barangay Council of Barangay San Jose, this city, entitled, "BARANGAY TAXATION FOR THE OBJECT: SARI-SARI STORE, #20.00, BARANGAY CASE FILING FEE, #10.00";

WHEREAS, this sanggunian, in relation to the aforecited ordinance at issue (and all other ordinances of the Sangguniang Barangay in Ormoc City) is, by law, granted with the power to review on whether the said ordinance is consistent with law and city X X X ordinances. LGC 1991);

WHEREAS, the Seventh Sangguniang Panlungsod ng Ormoc, through the representation of the Honorable Chairman, Committee on Laws and Ordinances, opted to return said Ordinance to the Barangay of Origin for the following reasons, to wit:

- Tax on stores or retailers with fixed business establishment shall be based on their gross sales or receipts of the preceding calendar year not to exceed P50,000 at rates not exceeding 1% thereof; and NOT on a fixed amount as provided for in his ordinance;
- There is no showing that the required public hearing prior to the passage of a tax ordinance has been complied with; SEC. ART. 274
- It is suggested that your tax ordinance zovers the taxable item provided for in Article 240 of the Aules and item provided for in Article 240 of the Regulations Implementing the Local Government Code 1991.

NOW, THEREFOFE, on motion of Vagawad Nariano Y. Corro. Chairman, Committee on Laws and Ordinances, jointly seconded by mga Kagawad Fernando P. Parrilla and Benjamin B. Lladoc; be it

RESOLVED, to pass a resolution RETURNING TO THE SANGGUNIANG BARANGAY OF BARANGAY SAN JOSE, THIS CITY, THEIR BARANGAY ORDINANCE NO. 2 S. 1995, ENTITLED, "BARANGAY TAXATION FOR THE OBJECT: SARI-SARI STORE, #20.00, BARANGAY CASE PILING FIE, #10.00", FOR THE REASONS STATED HEREUNDER, TO WIT

- TAX ON STORES ON FETAILERS WITH FIXED BUSINESS ESTABLISHMENT SHALL BE BASED ON THEIR GROSS SALES OR RECEIVES OF THE PRECEDING CALENDAR YEAR NOT TO EXCEED \$50,000,000 AT RATES NOT EXCEEDING 1% THEREOF; AND NOT ON A XED ANUMN AS PROVIDED FOR IN THIS ORDINANCE;
- MERE IS NO SHOWING THAT THE REQUIRED PUBLIC HEARING PRIOR PASSAGE OF A TAX ORDINANCE HAS BEEN COMPLIED WITH; 950. ART. 274
- IT IS SUGGESTED THAT YOUR TAX ORDINANCE COVERS THE TAXABLE ITEM PROVIDED FOR IN ARTICLE 240 OF THE RULES AND REGULATIONS IMPLEMENTING THE LOCAL GOVERNMENT CODE OF 1991.
