RESOLUTION NO. 95-107

A RESOLUTION SUPPORTING AND ENDORSING RESOLUTION NO. 95-269 OF THE SANGGUNIANG PANLUNGSOD NG NAGA CITY ENTITLED, "RESOLUTION STRONGLY DEPLORING AND OPPOSING ALL BILLS PENDING IN CONGRESS WHICH SEEK TO AMEND R.A. 7160 OTHERWISE KNOWN AS THE LOCAL GOVERNMENT CODE OF 1991 TO REDUCE THE CITIES' SHARE IN THE INTERNAL REVENUE ALLOTMENT (IRA) AND FURTHER PROPOSING CERTAIN RECOMMENDATIONS THEREOF".

WHEREAS, this august Body is in receipt of Resolution No. 95-269 dated 13 September 1995 of the Sangguniang Panlungsod of Naga City, entitled, "RESOLUTION STRONGLY DEPLORING AND OPPOSING ALL BILLS PENDING IN CONGRESS WHICH SEEK TO AMEND R.A. 7160 OTHERWISE KNOWN AS THE LOCAL GOVERNMENT CODE OF 1991 TO REDUCE THE CITIES' SHARE IN THE INTERNAL REVENUE ALLOTMENT (IRA) AND FURTHER PROPOSING CERTAIN RECOMMENDATIONS THEREOF";

WHEREAS, the Seventh Sangguniang Panlungsod ng Ormoc, through the representation of the Honorable Chairman, Committee on Finance respectfully recommends that this Sanggunian strongly supports the Resolution of the Sangguniang Panlungsod of Naga City by strongly deploing and opposing all bills pending in Congress which seek to amend R.A. 7160 otherwise known as the Local Government Code of 1991 by reducing the cities' share in the Internal Revenue Allotment (IRA);
