RESOLUTION NO. 95-111

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR
EUFRENDINO M. CODILLA, SR. TO SIGN, FOR AND IN BEHALF OF
THE CITY GOVERNMENT, A MEMORANDUM OF AGREEMENT BETWEEN
THE CITY GOVERNMENT AND THE ORMOC MIDTOWN TENNIS CLUB
RELATIVE TO THE CLUB'S INTENTION TO USE, MANAGE AND
SUPERVISE THE CITY'S TENNIS CLUB AT THE CITY GOVERNMENT
CENTER, WITH INSTRUCTIONAL REQUEST FOR COMPLIANCE
RELATIVE TO THE PROVISIONS IN PARS. 1, 7 & 13 OF SAID
MOA, AS AMENDED.

WHEREAS, this august Body is in receipt of 1st Indorsement dated 13
October 1995 from the Secretary to the City Mayor, for and in behalf of
the City Mayor, requesting for passage of a resolution authorizing the
Honorable City Mayor to sign, for and in behalf of the City Government
of Ormoc a Memorandum of Agreement with the Ormoc Midtown Tennis Club,
this city, relative to the Club's intention to use, manage and supervise
the City's Tennis Courts at the Government Center, this city;

WHEREAS, after review of said Memorandum of Agreement by this
august Body, it recommends for some amendments or changes thereof
particularly the following paragraphs which now read as follows:

Par. 1. That the Club should allow ONLY BONAFAIDE members
of the Club duly accredited by the CLUB's
Membership and SCREENING COMMITTEE to play and
enjoy such other benefits and priveleges;

Par. 7. That the Honorable City Mayor shall have the
prerogative to choose from among the Members of
the Sangguniang Panlungsod ng Ormoc as to who

shall represent in the Membership and Screening Committee who shall enjoy voting and screening rights;

Par. 13. This Memorandum of Agreement as deliberated and approved shall be subject to its ratification after it shall have been signed by the Honorable City Mayor;

WHEREAS, this Sanggunian, through the representation of the Honorable Chairman, Committee on Youth Development and Sports, has considered said request reasonable, hence, must be given due course;

NOW, THEREFORE, on motion of Kagawad Angelyn R. Paza, Chairman, Committee on Youth Development and Sports, duly seconded by Kagawad Claudio P. Larrazabal; be it

RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR EUFROCINO M. CODILLA, SR. TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT, A MEMORANDUM OF AGREEMENT BETWEEN THE CITY GOVERNMENT AND THE ORMOC MIDTOWN TENNIS CLUB RELATIVE TO THE CLUB'S INTENTION TO USE, MANAGE AND SUPERVISE THE CITY'S TENNIS CLUB AT THE CITY GOVERNMENT CENTER, WITH INSTRUCTIONAL REQUEST FOR COMPLIANCE RELATIVE TO THE PROVISIONS IN PARAS. 1, 7 & 13 OF SAID MOA, AS AMENDED;

ENACTED, November 3, 1995.

RESOLVED, FURTHER, to furnish copies of this resolution each to His Honor, the City Mayor; the City Administrator, the City Legal Officer, the President - Ormoc Midtown Tennis Club, and others concerned, -all in Ormoc City;

CARRIED by MAJORITY VOTES, with nine (9) affirmative votes and two (2) abstentions registered by mga Kagawad Mariano Y. Corro and Kagawad Gregorio A. Yrastorza, Jr.
