This is to respectfully request that august Body for the
passage of a resolution authorizing the City Mayor to enter
into a contract in behalf of the City Government of Ormoc
with Gwendolyn Garcia Codilla who will render the following
services at One Peso (P1.00) a year service fee:

1. Act as CONSULTANT ON FINANCIAL AND DEVELOPMENTAL AFFAIRS for the City of Ormoc;
2. Assist the City Government of Ormoc in establishing linkages between relevant government and private agencies, organizations and institution that can help the programs and projects of the city;
3. Assist in the preparation of a fund flow mechanism, accounting and disbursement procedures to be observed in the project implementation in accordance with Commission on Audit rules and regulations;
4. Perform such other functions as may be requested by the City Government of Ormoc represented by the City Mayor.




