RESOLUTION NO. 95-117

A RESOLUTION RESPECTFULLY INFORMING THE HONORABLE CITY
MAYOR THAT HIS REQUEST FOR AN AUTHORITY TO SIGN THE
DEED OF DONATION IN FAVOR OF THE BUREAU OF JAIL
MANAGEMENT AND PENOLOGY (BJMP) CANNOT BE ACTED
FAVORABLY BY THIS SANGGUNIANG FOR THE REASON THAT THE
PROPERTY PROPOSED TO BE DONATED IS NOT AN IDEAL SITE
FOR A JAIL ESTABLISHMENT.

WHEREAS, this august Body is in receipt of 1st Indorsement dated 16
October 1995 from the Honorable City Mayor earnestly requesting for
passage of a resolution authorizing the City Mayor to sign, for and in
behalf of the City Government of Ormoc, a Deed of Donation relative to
the titling of the lot donated by the City of Ormoc for the construction
of a jail building in favor of the Bureau of Jail Management and
Penology (BJMP);

WHEREAS, upon review by this august Body of the technical
descriptions of the proposed site of the BJMP Building, it was found out
that the property proposed to be donated is near the Ormoc City High
School, thereby causing a hazard to school children if and when a jail
shall be established in that area, and further, the proposed area to be
donated consist only of 1,035 square meters which is small for the
establishment of a jail building, hence, it was the consensus of the
Body that the said request cannot be acted upon favorably in view of the
aforecited reasons;

NOW, THEREFORE, on motion of Kagawad Mariano Y. Corro, Chairman,
Committee on Public Properties, duly seconded by Kagawad Sotero M.
Pepito; be it

RESOLVED, to pass a resolution RESPECTFULLY INFORMING THE HONORABLE CITY MAYOR THAT HIS REQUEST FOR AN AUTHORITY TO SIGN THE DEED OF DONATION IN FAVOR OF THE BUREAU OF JAIL MANAGEMENT (BJMP) CANNOT BE ACTED FAVORABLY BY THIS SANGGUNIANG FOR THE REASON THAT THE PROPERTY PROPOSED TO BE DONATED IS NOT AN IDEAL SITE FOR A JAIL ESTABLISHMENT;
