RESOLUTION NO. 95-119

A RESOLUTION SINCERELY COMMENDING COL. EUGENIO P. HONOR, GROUP COMMANDER, BRCDG, RESCOM, PHILIPPINE ARMY, FOR DILIGENT AND SINCERE DEDICATION TO HIS DUTIES, AND THE NOBLE DEEDS THAT HE HAS CONTRIBUTED TO THE CITY'S PROGRAMS AND PROJECTS.

WHEREAS, Col. EUGENIO P. HONOR, Group Commander, BRCDG, Philippine Army Reserve Command at Camp Downes, this city, will soon retire from military service, and presently called to report to Headquarter Reserve Command, Philippine Army, Camp Riego de Dios, Tanza, Cavite, thus his post as Group Commander is temporarily handled by Col. Jacinto S. Piquero, (GSC) PA, Deputy Commander/Ex-O, the latter having submitted the Accomplishment Data (per letter dated November 1995) of his Group Commander Col. Eugenio P. Honor to this Sanggunian upon request of the Secretary to the Sangguniang Panlungsod;

WHEREAS, as many Ormocanons have observed, Col. EUGENIO P. HONOR is a hard working military personnel who has rendered his military duties with utmost diligence and sincerity, and to mention some of his military accomplishments, are:

- a) Having dispatched three (3) teams of military personnel with an officer to augment the Ormoc City Police Command in order to have a peaceful, orderly and honest May 8, 1995 election in Ormoc City;
- b) Having assisted and personally supervised the rehearsal in preparation for the general oath taking ceremony of the newly elected officers of the Veterans Federation of the Philippines;

- c) Having dispatched two (2) teams of military personnel to augment with the Ormoc City Police Command to act as security during the Ormoc City Fiesta Celebration.

WHEREAS, in spite of his military activities, he has never failed to coordinate with the City Government of Ormoc whenever necessary with the city's programs, projects and other activities, such as:

- a) Active participation of the Alay Lakad activities as sponsored by the City Government;
- b) His coordination with the City Government on the Water Pump Project at Camp Downes which provided abundant and potable water not only to the military personnel at Camp Downes but also to the populace of Ormoc City;
- c) His coordination with the PNRC Ormoc City Chapter on series of bloodletting activities utilizing ROTC cadets as the donors, and was able to donate 25,000 cc of different types of blood.

WHEREAS, also to mention one great accomplishment of this fine officer, in line with the City Administration's Clean and Green Program, he initiated a tree planting activity and had caused the planting of 2,203 trees within Ormoc City, -this and other non-military undertakings have been contributed by this good soldier for the well-being of Ormoc City;

WHEREFORE, foregoing premises considered, on motion of Kagawad Sotero M. Pepito, Chairman, Committee on Good Government & Ethics, duly seconded by Kagawad Benjamin B. Lladoc; be it

RESOLVED, to pass a resolution SINCERELY COMMENDING COL. EUGENIO P. HONOR, GROUP COMMANDER, BRCDG, RESCOM, PHILIPPINE ARMY, FOR DILIGENT AND SINCERE DEDICATION TO HIS DUTIES, AND THE NOBLE DEEDS THAT HE HAS CONTRIBUTED TO THE CITY'S PROGRAMS AND PROJECTS;
