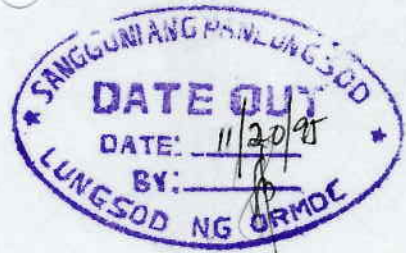

RESOLUTION NO. 95-125

A RESOLUTION GRANTING AUTHORITY TO HONORABLE CITY MAYOR EUFROCINO M. CODILLA, SR., TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, AS VENDEE, THE HERETO ATTACHED DEED OF EXTRA-JUDICIAL PARTITION AND SALE WITH THE HEIRS OF LORENZO GONZAGA.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 15 September 1995 from the City Legal Officer, requesting for passage of a resolution granting authority to the Honorable City Mayor to sign, for and in behalf of the City Government, as vendee, the Deed of Extra-Judicial Partition and Sale with the heirs of Lorenzo Gonzaga;

WHEREAS, this Deed of Extra-Judicial Partition and Sale pertains to

"A parcel of land (Lot 2349-B-1-A of the subdivision plan, Psd-08-002340, being a portion of Lot 2349-B-1, Psd-08-001389, L.R.C. Cad. Rec. No. 1572), situated in Barrio of Alegria, Ormoc City, covered by TRANSFER CERTIFICATE OF TITLE NO. 23536 of the Register of Deeds of Ormoc City, containing an area of 175 square meters, more or less;" with an unfinished building erected therein;

wherein the surviving heirs (lawful wife and children) of Lorenzo Gonzaga (deceased) have extrajudicially partitioned among themselves and simultaneously sold in favor of the City Government of Ormoc through Mayor Eufrocino M. Codilla, Sr., the said papers or Deed of Extra-Judicial Partition and Sale is already accomplished with signatures of vendors (heirs), said document is hereto attached, and, only wanting for a resolution granting authority to the Honorable City Mayor to sign the documents;

WHEREFORE, foregoing premises considered, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Public Properties, severally seconded by mga Kagawad Sotero M. Pepito, Fernando P. Parrilla and Benjamin B. Lladoc; be it
