is Sanggunian is in receipt of a letter dated 28 August the Monorable City Mayor, requesting this august Body for passage of resolution authorizing him to sign, for and in behalf of ty Government, the Deed of Absolute Sale of Lot No. 8-D (Road-(1) of-Way) of Mrs. Diosdada Valle Laurente, covered by TCT No. 26036, ted at Brgys.
