RESOLUTION NO. 95-127

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ENROCING M. CODILLA, SR., TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORmoc, AS VENDEE, THE DEED OF ABSOLUTE SALE OF LOT NO. 8-D (ROAD LOT) OF MRS. DIOSDADA VALLE LAURENTE, COVERED BY TCT NO. 26036, SITUATED AT BRGYS. ALEGRIA AND LINAQ, (RUVI VILLAGE), ORmoc CITY, WITH AN AREA OF 950 SQUARE METERS.

WHEREAS, this Sanggunian is in receipt of a letter dated 28 August 1995 from the Honorable City Mayor, requesting this august Body for passage of a resolution authorizing him to sign, for and in behalf of the City Government, the Deed of Absolute Sale of Lot No. 8-D (Road-Right-of-Way) of Mrs. Diosdada Valle Laurente, covered by TCT No. 26036, situated at Brgys. Alegria & Linao (Ruvi Village), this city, with an area of 950 square meters;

WHEREAS, two Certification dated 17 August 1995, each issued by the City Planning IV and the Geodetic Engineer- Tax Mapper IV, both have certified that said Lot No. 8-D with TCT No. 26036, registered in the name of Diosdada Valle, is traversed by an existing 20 meters wide City Road presently situated at Ruvi Village, this city;

WHEREAS, per Resolution No. 21-95 dated 9 November 1995 of the Ormoc City Appraisal Committee, Lot No. 8-D owned by Diosdada Valle is appraised at ₱250.00 per square meter;
