A RESOLUTION REQUESTING REGIONAL EXECUTIVE DIRECTOR AGUSTUS MOMONGAN OF THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) REGION 8, TACLOBAN CITY FOR THE ASSIGNMENT OF TWO (2) FORFEITED MOTOR BOATS FOR THE USE OF THE ORMOC CITY BANTAY DAGAT AND SIMILAR PURPOSES AND FURTHER TO AUTHORIZE THE CITY MAYOR TO SIGN THE MEMORANDUM OF AGREEMENT (MOA) IN CONNECTION WITH THE SAID ASSIGNMENT.

WHEREAS, per reliable sources, there are forfeited and confiscated motor boats which are in the possession of the Department of Environment and Natural Resources (DENR), Region 8, Tacloban City;

WHEREAS, Ormoc City is in need of motor boats for its use in the enforcement of fishery laws and other similar purposes which this august Body believes will be of great help and importance if ever said request is granted;

WHEREAS, the 7th SANGGUNIANG PANLUNGSOD ng ORMOC, through the representation of the Honorable Chairman, Committee on Natural Resources and Environmental Control has reached to a consensus that a Memorandum of Agreement (MOA) has to be executed by and between the DENR and the City of Ormoc represented by His Honor, the City Mayor in connection with the said assignment for purposes of repair and maintenance of the said motor boats;

NOW, THEREFORE, on motion of Kagawad Jose C. Alfaro, Jr., Chairman, Committee on Natural Resources and Environmental Control, jointly seconded by mga Kagawad Alfredo F. Capahi and Sotero M. Pepito; be it
