RESOLUTION NO. 95-132

A RESOLUTION TO APPROVE AND ADOPT "THE MODEL GUIDELINES, RULES AND REGULATIONS COVERING LGU-FUNDED INFRASTRUCTURE PROJECTS" WHICH WAS PREPARED BY THE PROVINCIAL ENGINEERS ASSOCIATION OF THE PHILIPPINES (PEAP) IN COORDINATION WITH THE NEDA-INFRA STAFF, AND DILG-OPDS, AS THE GUIDELINES, RULES AND REGULATIONS COVERING INFRASTRUCTURE PROJECTS OF THE CITY GOVERNMENT OF ORMOC, EFFECTIVE IMMEDIATELY.

WHEREAS, this august Body is in receipt of a letter dated November 13, 1995 of the Honorable City Mayor Eufrocino M. Codilla, Sr., requesting "for your approval our guidelines, rules and regulations on the bidding, processing, awarding and implementation, to be adopted by the Local Pre-qualifications, Bids and Awards Committee (PBAC) on the LGU-funded infrastructure projects.";

WHEREAS, the Local Government Code of 1991 (R.A. 7160), particularly Section 534(d), repealed Presidential Decree No. 1594 (Prescribing Policies, Guidelines, Rules and Regulations For Government Infrastructure Contracts) including its implementing rules and regulations, insofar as it governs locally funded projects;

WHEREAS, Memorandum Circular No. 94-185 dated October 20, 1994, of DILG Secretary Rafael M. Alunan III, has stated that with the repeal of PD1594, LGUs are now allowed to adopt their own guidelines, rules and regulations on the bidding, processing, awarding and implementation of LGU funded Infrastructure Projects;

WHEREAS, the aforementioned Memorandum Circular of DILG Secretary Rafael M. Alunan III, further states:

"For these considerations and in order to obviate possible confusion/problems that may result due to the absence of uniform set of guidelines, the Provincial Engineers' Association of the Philippines (PLEAP) in consultation with the Leagues of Provinces, Cities and Barangays; the Technical Working Group of the Oversight Committee for the Local Government Code; the National Economics and Development Authority (NEDA) and the Department of the Interior and Local Government (DILG), prepared a Model Guidelines, Rules and Regulations Governing LGU-funded Infrastructure Projects for possible adoption by all LGUs." (Underscoring supplied)

WHEREFORE, foregoing premises considered, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Laws and Ordinances, severally seconded by mga Kagawad Gregorio A. Yrastorza, Jr., Alfredo F. Capahi, Claudio P. Larrazabal and Benjamin B. LLadoc, be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution TO APPROVE AND ADOPT "THE MODEL GUIDELINES, RULES AND REGULATIONS COVERING LGU-FUNDED INFRASTRUCTURE PROJECTS" WHICH WAS PREPARED BY THE PROVINCIAL ENGINEERS ASSOCIATION OF THE PHILIPPINES (PEAP) IN COORDINATION WITH THE NEDA-INFRA STAFF, AND DILG-OPDS, AS THE GUIDELINES, RULES AND REGULATIONS COVERING INFRASTRUCTURE PROJECTS OF THE CITY GOVERNMENT OF ORMOC, EFFECTIVE IMMEDIATELY;

ENACTED, November 23, 1995.

RESOLVED, FURTHER, to furnish copies of this Resolution, one each, to Honorable City Mayor Eufrocino M. Codilla, Sr., City Administrator Vicente Redoña, and all Members of the Local PEAC; the President of the Ormoc City Contractor, the City Auditor, and all others concerned;
