RESOLUTION NO. 95-133

A RESOLUTION RESPECTFULLY INFORMING THE HONORABLE CITY  
MAYOR EUFROCINO M. CODILLA, SR., THAT HENCEFORTH NOT  
ALL ENACTMENTS OF THIS SANGGUNIAN WILL BE TRANSMITTED  
TO HIS OFFICE FOR APPROVAL, BUT WILL BE LIMITED TO:  
A) ORDINANCES; B) APPROPRIATION ORDINANCES; C)  
ORDINANCES OR RESOLUTIONS ADOPTING A LOCAL DEVELOPMENT  
PLAN AND PUBLIC INVESTMENT PROGRAM; AND D) ORDINANCE  
DIRECTING THE PAYMENT OF MONEY OR CREATING LIABILITY.

WHEREAS, the present practice is to transmit all enactments passed  
by the Sanggunian to the Office of the City Mayor for approval;

WHEREAS, the Local Government Code of 1991, as well as its  
Implementing Rules and Regulations, does not require that all enactments  
passed by the Sanggunian be transmitted to the Office of the City Mayor  
for approval;

WHEREAS, to relieve the Office of the City Mayor the burden of  
going-over, scrutinizing and signing all measures passed by the  
Sanggunian, and to give him more time to attend to the more important  
functions of his Office, then, only those measures which are required by  
law to be transmitted to him shall be submitted for his appropriate  
action;

WHEREFORE, on motion of Kagawad Mariano Y. Corro, Chairman,  
Committee on Internal Rules, duly seconded by Kagawad  
Benjamin B. Lladoc; be it

RESOLVED, AS IT IS HEREBY, to pass a resolution RESPECTFULLY  
INFORMING THE HONORABLE CITY MAYOR EUFROCINO M. CODILLA, SR., THAT  
HENCEFORTH NOT ALL ENACTMENTS OF THIS SANGGUNIAN WILL BE TRANSMITTED TO

HIS OFFICE FOR APPROVAL, BUT WILL BE LIMITED TO: A) ORDINANCES; B) APPROPRIATION ORDINANCES; C) ORDINANCES OR RESOLUTIONS ADOPTING A LOCAL DEVELOPMENT PLAN AND PUBLIC INVESTMENT PROGRAM; AND D) ORDINANCE DIRECTING THE PAYMENT OF MONEY OR CREATING LIABILITY;

ENACTED, November 23, 1995.
