RESOLUTION NO. 95-143

A RESOLUTION TO INFORM THE HONORABLE CITY MAYOR EUFROCINO M. CODYLLA, SR., THAT HIS REQUEST FOR AN AUTHORITY TO SIGN FOR AND IN REHALT OF THE CITY GOVERNMENT OF ORMOC. AS DONO! THE ATTACHED DEED OF DONATION IN FAVOR OF THE BUSERU OF JRIL MANAGEMENT AND PENOLOGY (BJMP) IS HEREBY GRANTED. HOWEVER, IT IS SUGGESTED THAT A PROVISO BE INCOMPARATED THEREIN THAT THE OWNERSHIP OF THE PROPERTY DOMATEN SHALL REVERT TO THE CITY GOVERNMENT OF ORMOC 18:

- THE PROPERTY IS NOT UTILIZED AS A JAIL SITE OR NO LONGER USED AS JAIL SITE.
- THE CONSTRUCTION OF THE JAIL IS NOT COMMENCED WITHIN SIX (6) MONTHS FROM THE DATE OF THE EXECUTION OF THE DEED OF DONATION.

WHEREAS, this august Body is in receipt of a letter from the Honorable City Mayor dated 9 November 1995 addressed the Honorable Members of the 7th Sangguniang Panlungsod, this city, thru the Honorable Vice Mayor & Presiding Officer requesting for an authority to sign for and in behalf of the City Government of Ormoc as Donor, a Deed of Donation in favor of the Bureau of Jail Management and Penology (BJMP) for a parcel of lot (Lot 1628-A-3-A-1) with an area of 2,210 sq. m. situated at Barangay Alta Vista, this city to be used as site for the BJMP building:

WHEREAS, this august Body, upon review of said Deed of Donation has considered said request reasonable, hence, must be given due course, however, it is suggested that a proviso be incorporated therein that the ownership of the the property donated shall revert to the City Government of Ormoc if:

- The property is not utilized as a jail site or no longer used as jail site.
- The construction of the jail is not commenced within six (6) months from the date of the execution of the Deed of Donation.

WHEREFORE, PREMISES CONSIDERED, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Public Properties, severally seconded by mga Kagawad Claudio P. Larrazabal, Sotero M. Pepito and Alfredo F. Capahi; be it

RESOLVED, to pass a resolution to inform the honorable Sity mayor EUFROCINO M. CODILLA, SR., THAT HIS REQUEST FOR AN AUTHORITY TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, AS DONOR, THE ATTACHED DEED OF DONATION IN FAVOR OF THE BUREAU OF JAIL MANAGEMENT AND AENOLOGY (BJMP) IS HEREBY GRANTED. HOWEVER, IT IS SUGGESTED THAT A PROVISO BE INCORPORATED THEREIN THAT THE OWNERSHIP OF THE PROPERTY DONATED SHALL REVERT TO THE CITY GOVERNMENT OF ORMOC IF:

- 1) THE PROPERTY IS NOT UTILIZED AS A JAIL SITE OF NO LONGER USED AS JAIL SITE.
- THE CONSTRUCTION OF THE JATL IS NOT COMMENCED WITHIN SIX (4) MONTHS FROM THE DATE OF THE EXECUTION OF THE DEED OF DONATION;

RESOLVED, FURTHER, to furnish copies of this resolution each to His Honor, the City Mayor; Supt. Virgilio Tenebro, BJMP, Tacloban City, INSP Juanito C. Catioax, BJMP, Ormoc City, the City Administrator, the City Legal Officer, the Registrar, Register of Deeds, the Barangay Chairman of Brgy. Alta Vista and others concerned, -in Ormoc city;
