RESOLUTION NO. 95-144

A RESOLUTION TO INFORM THE REGIONAL TECHNICAL DIRECTOR, LANDS MANAGEMENT SERVICE, DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR), TACLOBAN CITY, THAT THE MUNICIPAL OFFICIALS OF KANANGA, LEYTE HAVE NOT FURNISHED THE CITY OFFICIALS OF ORMOC, PARTICULARLY THE MEMBERS OF THIS SANGGUNIANG, THEIR POSITION PAPER ON THE POLITICAL BOUNDARY DISPUTE BETWEEN THE CITY OF ORMOC AND THE MUNICIPALITY OF KANANGA AS AGREED DURING THE TECHNICAL MEETING LAST OCTOBER 17, 1995, AND ADDITIONALLY, TO REQUEST THAT OFFICE TO FURNISH THIS SANGGUNIANG THE REQUESTED VALIDATED MAP AND TECHNICAL DESCRIPTIONS AS EMBODIED IN THEIR RESOLUTION NO. 95-74.

WHEREAS, last October 17, 1995, the Municipal Officials of Kananga, led by Honorable Mayor Eduardo Napari, and the City Officials of Ormoc, led by Honorable Vice Mayor Benjamin F. Tugonon, upon invitation of the Regional Technical Director, Lands Management Service, Department of Environment and Natural Resources, Tacloban City, met at his Office to thresh out the boundary conflict between their respective LGU;

WHEREAS, in the aforementioned meeting, the parties agreed that the Municipal Officials of Kananga will submit their position paper on the matter within thirty (30) days therefrom furnishing a copy thereof the City Officials of Ormoc who will in turn submit their rejoinder within the same period furnishing a copy thereof the Municipal Officials of Kananga;

WHEREAS, the period given to the Municipal Officials of Kananga within which to submit their position paper has already expired but unfortunately the City Officials of Ormoc, particularly the members of this Sangguniang have not received a copy of the promised position paper;

WHEREAS, the members of this Sanggunian do not expect to receive anymore the position paper of the Municipality of Kananga on the boundary dispute between the said Municipality and the City of Ormoc;

WHEREAS, in order to settle this controversy once and for all, this Sanggunian will now take the necessary appropriate action for the attainment thereof;

WHEREAS, one of the vital documents required in the settlement of boundary dispute as provided for in the Local Government Code of 1991 (RA No. 7160) is the technical description of the boundaries of the Municipality of Kananga, Leyte and the City of Ormoc, with their corresponding maps duly certified by the Lands Management Service which document was already requested from said Office per Resolution No. 95-74 enacted on September 21, 1995 of this Sanggunian, which was sent to that Office on October 2, 1995, per registry receipt no. A4605, a copy of said Resolution No. 95-74 is hereto attached for ready reference.

FOREGOING PREMISES CONSIDERED, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Public Properties, severally seconded by mga Kagawad Sotero M. Pepito, Celso P. Adolfo and Alfredo F. Capahi; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution TO INFORM THE REGIONAL TECHNICAL DIRECTOR, LANDS MANAGEMENT SERVICE, DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR), TACLOBAN CITY, THAT THE MUNICIPAL OFFICIALS OF KANANGA, LEYTE HAVE NOT FURNISHED THE CITY OFFICIALS OF ORMOC, PARTICULARLY THE MEMBERS OF THIS SANGGUNIAN, THEIR POSITION PAPER ON THE POLITICAL BOUNDARY DISPUTE BETWEEN THE CITY OF ORMOC AND THE MUNICIPALITY OF KANANGA, AS AGREED DURING THE TECHNICAL MEETING LAST OCTOBER 17, 1995 AND ADDITIONALLY, TO REQUEST THAT OFFICE TO FURNISH THIS SANGGUNIAN THE REQUESTED VALIDATED MAP AND TECHNICAL DESCRIPTIONS AS EMBODIED IN THEIR RESOLUTION NO. 95-75;
