A RESOLUTION EARNESTLY REQUESTING THE MANAGEMENT OF THE
UNIVERSAL ABOITIZ INCORPORATED TO ASSIGN PRE-NUMBERED
SEATS TO PASSENGERS OF THE SUPERCAT VESSELS SO AS TO
AVOID INCONVENIENCE TO THE COMMUTERS.

WHEREAS, the Universal Aboitiz Inc. has assigned two (2) units of
its Super Cat Vessels to ply the route Cebu-Ormoc and vice-versa in view
of the increase in demand of the commuters as well as the increasing
number of passengers plying the said route;

WHEREAS, however, the City Government of Ormoc is aware of the
inconvenience of the passengers taking the Super Cat Vessels plying the
Ormoc-Cebu route and vice-versa because there are no pre-assigned seats
to its passengers, hence, there is a scramble for seats everytime the
said vessels arrive at the Ormoc City Port;

WHEREAS, this august Body suggested to the Manager, Aboitiz
Shipping Corporation, Ormoc City to make representations to the higher
Management of the Universal Aboitiz Inc. regarding this issue and
further expresses its support by way of this resolution for the benefit
of the riding public;

WHEREFORE, foregoing premises considered, on MASS MOTION of the
Body and with OVERWHELMING SECONDS; be it

RESOLVED, to pass a resolution EARNESTLY REQUESTING THE MANAGEMENT
OF THE UNIVERSAL ABOITIZ INCORPORATED TO ASSIGN PRE-NUMBERED SEATS TO
PASSENGERS OF THE SUPERCAT VESSELS SO AS TO AVOID INCONVENIENCE TO THE
COMMUTERS;
