RESOLUTION NO. 95-151

A RESOLUTION DIRECTING THE OIC-CITY TREASURER, ORmoc CITY, TO RELEASE THE ADDITIONAL INCENTIVE ALLOWANCE FOR PUBLIC SCHOOL TEACHERS IN THE AMOUNT OF P300.00 EACH FROM JULY TO DECEMBER, 1995 PURSUANT TO ARTICLE 363 OF THE RULES AND REGULATIONS IMPLEMENTING THE LOCAL GOVERNMENT CODE OF 1991.

WHEREAS, this august Body is in receipt of a letter dated 6 December 1995 from the President, Ormoc City Public School Teachers Association (OCPSTA) relative to the incentive of teachers from the period July to December which was approved through Supplemental Budget for CY 1995 by the Local School Board;

WHEREAS, the City Legal Officer through 3rd Indorsement dated 21 September 1995 has opined that "X.X X Article 363 of the Rules and Regulations Implementing the Local Government Code allows the 1% of the SEF Tax to be used for the payment of salaries of teachers because it provides:

'Article 363 (c) (1) operation and maintenance of public schools'.

Operation and maintenance of public schools necessarily embrace the payment of salaries to teachers";

WHEREAS, this Sanggunian, through the representation of the Honorable Vice Chairman, Committee on Education and Cultural Development has considered said request valid and reasonable, hence, must be given due course;

NOW, THEREFORE, on motion of Kagawad Manuel T. Fiel, Vice Chairman, Committee on Education and Cultural Development, jointly seconded by mga Kagawad Angelyn R. Paca and Jose C. Alfaro, Jr.; be it



ENACTED, December 14, 1995.


