A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EURECINO M. CODILLA, SR., TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, A DEED OF DONATION OF A PARCEL OF LAND CONSISTING OF 3,037 SQUARE METERS, PART OF LOT NO. 3571 TO BE USED AS SCHOOL SITE FOR SAN JOSE NATIONAL HIGH SCHOOL LOCATED AT BARANGAY SAN JOSE, ORMOC CITY.


