A RESOLUTION TO REFER TO THE CITY LEGAL OFFICER, ATTY.
CLETO L. EVANGELISTA, JR., THE MEMORANDUM OF THE
MUNICIPALITY OF KANANGA, PETITIONER, VERSUS, ORMOC
CITY, OPPOSITOR, RE: APPROVAL OF THE POLITICAL
BOUNDARY SURVEY OF KANANGA, LEYTE, WITH THE REQUEST
THAT A COUNTER MEMORANDUM BE PREPARED TO BE FILED WITH
THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES,
REGION 08, TACLOBAN CITY, WITHIN THIRTY DAYS FROM
DECEMBER 14, 1995, COPY FURNISHED THE COUNSEL FOR
PETITIONER.

WHEREAS, in the meeting called by the Regional Technical Director,
Department of Environment and Natural Resources, Region 08, Tacloban
City, anent the boundary dispute between the City of Ormoc and the
Municipality of Kananga, Leyte, last October 17, 1995, presided by Engr.
Mamerto Infante, Chief of the Survey Division, it was agreed by the
contending parties, that the Municipality of Kananga will submit its
position paper on the matter at issue within thirty (30) days from
October 17, 1995, furnishing a copy thereof the City of Ormoc, which in
turn is given the same period of thirty (30) days from receipt of said
copy within which to file its counter memorandum furnishing a copy
thereof the Municipality of Kananga;

WHEREAS, last December 14, 1995, the Office of the City Mayor of
Ormoc received a copy of the Memorandum of the Municipality of Kananga
on the aforementioned boundary conflict;

WHEREAS, as mentioned above, the City of Ormoc is required to file
its counter memorandum so as to ventilate its position on the boundary
conflict between the Municipality of Kananga and the City of Ormoc;

WHEREFORE, on motion of Kagawad Mariano Y. Corro, Chairman,
Committee on Public Properties, duly seconded by Kagawad Benjamin B.
Lladoc; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution to refer to the City Legal Officer, Atty. Cleto L. Evangelista, Jr., the Memorandum of the Municipality of Kananga, Petitioner, versus, Ormoc City, Oppositor, re: Approval of the Political Boundary Survey of Kananga, Leyte, with the request that a Counter Memorandum be prepared to be filed with the Department of Environment and Natural Resources, Region 08, Tacloban City, within thirty days from December 14, 1995, copy furnished the counsel for Petitioner;

RESOLVED, further, to furnish copies of this resolution each to The Honorable City Mayor, Eufrocino M. Codilla, Sr.; the City Legal Officer, Atty. Cleto L. Evangelista, Jr.; and all others concerned, in Ormoc City;
