SUBJECT: Negotiated contract for Scheme Phase II construction of Ormoc Coliseum

Hon. Tugonon,

As per Resolution of the Pre-Qualification, Bids and Awards Committee (PBAC), relative of the implementation of the Scheme for Phase II of the Ormoc City Coliseum. I am convinced that awarding it to the existing Contractor, MAC Builders, through a negotiated contract would be most advantageous to the City Government.

RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR TO ENTER INTO A NEGOTIATED CONTRACT, THE COMSTRUCTION OF PHASE II OF OMROC CITY COLISION IN THE AMOUNT OF NOT MORE THAN #30,026,542.20 WITH THE EXISTING CONTRACTOR OF PHASE I. MAC BUILDERS.
