THE CITY GOVERNMENT OF ORmoc, A MEMORANDUM OF AGREEMENT
WITH THE INSULAR LIFE ASSURANCE CO., LTD. THE INSURANCE
COVERAGE FOR ALL QUALIFIED AND REGULAR EMPLOYEES, THE
PROPOSED DRAFT IS HERETO ATTACHED.

WHEREAS, this august Body is in receipt of 1st Indorsement from the
Honorable City Mayor dated 5 December 1995 forwarded to the Honorable
Vice Mayor & Presiding Officer requesting this Sanggunian to pass a
resolution authorizing the City Mayor to sign for and behalf of the City
Government of Ormoc the attached Memorandum of Agreement relative to
proposal for Group Insurance coverage for all qualified and Regular
Employees of the City Government from Insular Life Assurance Co. Ltd.;

WHEREAS, said Group Insurance coverage will serve as an additional
benefit that will accrue to regular or qualified employees of the City
Government of Ormoc without any contribution on their part since the
premium will be shouldered by the City Government;

WHEREAS, the proposed Group Insurance coverage be the Insular Life
and Assurance Co., Ltd., is in relation to Section 458 No. 1 of par. A
of R.A. 7160;

WHEREAS, the 7th Sangguniang Panlungsod ng Ormoc mindful of the
benefits that the said Insurance coverage can extend to the
qualified City Government employees, has considered said request valid
and reasonable, hence, must be given the necessary, course of action;

Floor Leader, duly seconded by Kagawad Mariano Y. Corro; be it

THE INSURANCE COVERAGE FOR ALL QUALIFIED AND REGULAR EMPLOYEES, THE PROPOSED DRAFT IS HERETO ATTACHED;
