A RESOLUTION APPROVING THE APPLICATION FOR BUILDING PERMIT OF THE HOUSING PROJECT AT VILLA THERESA SUBDIVISION OWNED BY SPOUSES MANUEL CHUA AND THERESA CHUA WITH SUBDIVISION APPROVAL NO. 041-95, PER SP RESOLUTION NO. 95-55 DATED SEPTEMBER 7, 1995 HAVING AN AREA OF 9,197 SQ. M. CONTAINING 58 SUBDIVISION LOTS AND 47 UNITS/BUILDING LOCATED AT BARANGAY LINAO, ORMOC CITY SUBJECT TO THE PROVISIONS SET FORTH IN SECTION 14, RULE IV OF THE RULES AND STANDARDS FOR ECONOMIC AND SOCIALIZED HOUSING PROJECTS AND STANDARDS IMPLEMENTING D.P. 220.

PRESENTED, for consideration by this august Body is the following:

An Application for approval for a Building Permit of the Housing Project at Villa Theresa Subdivision owned by Sps. Manuel and Theresa Chua with Subdivision Approval No. 041-95 per SP Resolution No. 95-55 dated 7 September 1995.

WHEREAS, the authority to process, approve or disapprove building permit applications for economic and socialized housing projects has been devolved to the Sangguniang Panlungsod as per Section 458 of R.A. 7160, E.O. 71, B.P. Bldg. 220 and the opinion of the Head of the Legal Section of HLRB, Region VIII in his letter dated 21 December 1995;

WHEREAS, this august Body has found the aforesaid application to be in order, with the site of the on-going construction project duly inspected and the submitted documents and other papers have shown that the said application is in accordance with the provisions of R.A. 7160, P.D. 957, R.A. 7279, E.O. 648 and R.A. 7160 and its implementing rules and regulations. Further, said application is also subject to the provisions set forth in Section 14 Rule IV of the Rules and Standards for Economic and Socialized Housing Project per Legal opinion of the Head of the Legal Section, HLRB, Region VIII, Tacloban City dated 21 December 1995;

NOW, THEREFORE, on motion of Kagawad Manuel T. Fiel, Chairman, Committee on Zoning and Beautification jointly seconded by mga Kagawad Sotero M. Pepito and Alfredo F. Capahi, be it
