WHEREAS, this Sanggunian is in receipt of a letter dated 4 January, 1996 from the Honorable City Mayor, addressed the Honorable Members of the 7th Sangguniang Panlungsod ng Ormoc, thru the Honorable Vice Mayor & Presiding Officer earnestly requesting this august Body to pass a resolution confirming the creation and composition of the Prequalification, Evaluation and Awards Committee pursuant to NEDA Guidelines 313;

WHEREAS, said Committee was created through Executive Order No. 012-1995, "AN ORDER CREATING THE PREQUALIFICATION, EVALUATION AND AWARDS COMMITTEE", issued by the Honorable City Mayor, Eufrocino M.
