A RESOLUTION EXTENDING THE DEADLINE FOR
REGISTRATION/RENEWAL OF PERMITS/LICENSING OF BUSINESS
FROM JANUARY 20 TO FEBRUARY 15, 1996 DUE TO THE TIGHT
FINANCIAL SITUATION ENCOUNTERED BY THE MEMBERS OF THE
ORMOC FILIPINO RETAILERS ASSOCIATION (OFRA).

WHEREAS, this Sanggunian is in receipt of a letter dated 15 January 1996 from the President, Ormoc Filipino Retailers Association (OFRA) addressed to His Honor, the City Mayor and, the latter having endorsed the same to this august Body for appropriate action, said letter having requested for an extension of the Deadline of the renewal of the City Licenses/Mayor's Permits from January 20, 1996 to March 15, 1996 due to the tight financial situation encountered by the members of the Ormoc Filipino Retailers Association (OFRA);

WHEREAS, the Honorable City Mayor through 1st Indorsement dated 15 January 1996 has requested this august Body for the passage of a resolution granting said request of the OFRA up to February 15, 1996 only;

WHEREAS, in view of the aforecited request of the Honorable City Mayor, this august Body has considered reasonable to grant said request for an extension of the deadline of the renewal of the city licenses/Mayor's Permit from January 20, 1996 to February 15, 1996 only;

NOW, THEREFORE, on motion of Kagawad Alfredo F. Capahi, Chairman, Committee on Finance jointly seconded by mga Kagawad Sotero M. Pepito and Benjamin B. Lladoc; be it

RESOLVED, to pass a resolution EXTENDING THE DEADLINE FOR REGISTRATION/RENEWAL OF PERMITS/LICENSES OF BUSINESS FROM JANUARY 20, 1996 TO FEBRUARY 15, 1996 DUE TO THE TIGHT FINANCIAL SITUATION ENCOUNTERED BY THE MEMBERS OF THE ORMOC FILIPINO RETAILERS ASSOCIATION (OFRA);
