RESOLUTION NO. 96-13

A RESOLUTION CONCURRING AND SUPPORTING RESOLUTION NO. 95-324 OF THE SANGGUNIANG PANLUNGSOD NG NAGA, ENTITLED, "RESOLUTION EXPRESSING THE OPPOSITION OF THE 5TH SANGGUNIANG PANLUNGSOD OF THE CITY OF NAGA TO HOUSE BILL NO. 1704, REDUCING THE SHARES OF CITIES AND THE BARANGAY IN THE INTERNAL REVENUE ALLOTMENT (IRA)" FOR THE REASONS STATED THEREIN AND IN ADDITION THERETO IT IS ONLY BUT FAIR AND EQUITABLE THAT THE COST OF THE DEVOLVED FUNCTIONS SHOULD BE BORNE BY THE LGUs CONCERNED AFTER ALL THEY ARE THE RECEPIENT OF THE BENEFITS THEREFOR.

WHEREAS, this Sanggunian is in receipt of Resolution No. 95-324 of the Sangguniang Panlungsod ng Naga entitled, "RESOLUTION EXPRESSING THE OPPOSITION OF THE 5TH SANGGUNIANG PANLUNGSOD OF THE CITY OF NAGA TO HOUSE BILL NO. 1704 REDUCING THE SHARES OF CITIES AND THE BARANGAY IN THE INTERNAL REVENUE ALLOTMENT (IRA)";

WHEREAS, said House Bill No. 1704 proposes that "starting 1996 and the subsequent years, the actual costs of the devolved functions and personnel, and the cost of the city or municipality funded hospitals, less capital outlay shall first be deducted from the total IRA, and balance of the IRA shall be allocated to the LGUs";

WHEREAS, the 7th Sangguniang Panlungsod ng Ormoc through the representation of the Honorable Chairman, Committee on Laws and Ordinances, expresses its support and concern to the Sangguniang Panlungsod ng Naga by way of this resolution and supports the said resolution for the same reasons stated therein, and in addition thereto it is only but fair and equitable that the cost of the devolved functions should be borne by the LGUs concerned after all they are the recepients of the benefits therefor;

NOW, THEREFORE, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Laws and Ordinances jointly seconded by mga Kagawad Sotero M. Pepito and Benjamin B. Lladoc; be it

RESOLVED, to pass a resolution CONCURRING AND SUPPORTING RESOLUTION NO. 95-324 OF THE SANGGUNIANG PANLUNGSOD NG NAGA, ENTITLED, "RESOLUTION EXPRESSING THE OPPOSITION OF THE 5TH SANGGUNIANG PANLUNGSOD OF THE CITY OF NAGA TO HOUSE BILL NO. 1704, REDUCING THE SHARES OF CITIES AND THE BARANGAY IN THE INTERNAL REVENUE ALLOTMENT (IRA)" FOR THE REASONS STATED THEREIN AND IN ADDITION THERETO IT IS ONLY BUT FAIR AND EQUITABLE THAT THE COST OF THE DEVOLVED FUNCTIONS SHOULD BE BORNE BY THE LGUs CONCERNED AFTER ALL THEY ARE THE RECEPIENT OF THE BENEFITS THEREFOR;
