TO READ AS FOLLOWS: A RESOLUTION APPROVING THE 1996
DEVELOPMENT PROJECTS OF THE CITY OF ORMOC IN THE AMOUNT
OF SEVENTY SEVEN MILLION THREE HUNDRED NINETY FIVE

WHEREAS, this Sanggunian is in receipt of sisters Resolutions Nos.
1 & 2, both series of 1996, from the Executive Committee of the City
Development Council, this city, entitled:

THE CITY DEVELOPMENT COUNCIL.

RESOLUTION, the afore-titled Resolution No. 1 s. 1996 of the CDC
Executive Committee was passed but to amend CDC Resolution No. 7 s. 1995
which was already approved by the Sangguniang Panlungsod per SP
Resolution No. 95-145 s. 1995, however, funding for its development
projects amounting to P77,395,450.79 has not been allocated for the year
1995, hence, the said projects are now carried out as development
projects for year 1996 and, its breakdown or listing of the development
projects for the year 1995, as passed on to this year 1996, is in
"Status Quo", which breakdown can be found in SP Resolution No. 95-145
s. 1995, as attached;

WHEREAS, CDC Exec. Com. Resolution No. 2 s. 1996 has requested this Sanggunian for approval of its CDC Exec. Com. Resolution No. 1 s. 1996, the latter resolution is actually with the same development projects as cited in CDC Resolution No. 7 s. 1996, only that the year of implementation for reason of funding allocations is amended thus to be carried out this year 1996;

WHEREFORE, foregoing premises considered, on motion of Kagawad Claudio P. Larrazabal, Chairman, Committee on Infrastructures, jointly seconded by mga Kagawad Sotero M. Pepito and Benjamin B. Lladoc, be it
