A RESOLUTION APPROVING ORDINANCE NO. 95-003 OF THE
SANGGUNIANG BARANGAY OF BARANGAY NAUNGAN, THIS CITY,
ENTITLED, "AN ORDINANCE REQUIRING THE INDIVIDUAL TO PAY
AN AMOUNT OF TWENTY PESOS (P20.00) AS FILING FEE FOR
THOSE WHO MAY WANT TO FILE A CAUSE OF ACTION AGAINST
ANOTHER INDIVIDUAL INVOLVING ANY MATTER WITHIN THE
AUTHORITY OF THE LUPON."

WHEREAS, this Sanggunian is in receipt of Resolution No. 12 s. 1995
embodying Ordinance No. 95-003 of the Sangguniang Barangay of Barangay
Naungan, this city, entitled, "AN ORDINANCE REQUIRING THE INDIVIDUAL TO
PAY AN AMOUNT OF TWENTY PESOS (P20.00) AS FILING FEE FOR THOSE WHO MAY

within the province of the Sangguniang Barangay of Barangay Naungan to
legislate;
