RESOLUTION NO. 96-24

A RESOLUTION GRANTING THE REQUEST OF THE ORMOC FILIPINO
RETAILERS' ASSOCIATION (OFRA) FOR AN EXTENTION OF THE
DEADLINE OF THE RENEWAL OF THE CITY LICENSES/MAYOR'S
PERMIT FROM FEBRUARY 15, 1996 TO MARCH 20, 1996.

WHEREAS, this Sanggunian has passed Resolution No. 96-10 dated 18
January 1996 entitled, "A RESOLUTION EXTENDING THE DEADLINE FOR
REGISTRATION/RENEWAL OF PERMITS/LICENSING OF BUSINESS FROM JANUARY 20 TO
FEBRUARY 15, 1996 DUE TO THE TIGHT FINANCIAL SITUATION ENCOUNTERED BY
THE MEMBERS OF THE ORMOC FILIPINO RETAILERS' ASSOCIATION (OFRA)";

WHEREAS, recently however, the President of the Ormoc Filipino
Retailers' Association (OFRA) through a letter dated 6 February 1996
addressed the Honorable City Mayor, the latter having endorsed the same
to this august Body for appropriate action, has requested for another
extension of the deadline for the renewal of the City Licenses/Mayor's
Permits from February 15, 1996 to March 20, 1996 citing therein that the
majority of its members have not yet fully complied with the requisites
for the issuance of City Licenses/Mayor's Permits especially the
additional requirement- the BIR Tax Clearance and E-VAT registration and
other tax increase/adjustments;

WHEREAS, in view of the aforecited reasons, this august Body has
considered reasonable to temporarily suspend the operation of Section
1.2.1.4 of Tax Ordinance No. 1 S. 1974, otherwise known as the "Ormoc
City Revenue Code of 1977," fixing the first twenty (20) days of January
to pay tax obligations to the government, to provide not only the
members of the aforementioned retailers association, but also all
taxpayers with ample time to meet the various requirements regarding
tax obligations;

NOW, THEREFORE, on motion of Kagawad Alfredo F. Capahi, Chairman, Committee on Trade, Commerce and Cooperatives duly seconded by Kagawad Benjamin B. Lladoc; be it


