A RESOLUTION REQUESTING DIRECTOR DENNIS B. ARAULIO, CESO III OF THE BUREAU OF FISHERIES AND AQUATIC RESOURCES, (BFAR) DEPARTMENT OF AGRICULTURE TO DONATE TWO (2) UNITS FIBER GLASS PATROL BOATS TO ORMOC CITY LOCAL GOVERNMENT UNIT, FOR THE USE IN THE ENFORCEMENT OF FISHERY LAWS IN ORMOC BAY AND IN CONNECTION WITH THE ORMOC BAY MANAGEMENT COUNCIL ACTIVITIES.

WHEREAS, per information, it has come to the knowledge of the Honorable Chairman, Committee on Natural Resources and Environmental Control that there are available Fiber Glass Patrol Boats from the Bureau of Fisheries and Aquatic Resources (BFAR), Department of Agriculture;

WHEREAS, Ormoc Bay is among those given priority concern as a protected Bay under the Fisheries Sector Program;

WHEREAS, the enforcement of the Fishery Laws in the Ormoc Bay area has some difficulties due to lack of sea craft to be utilized in this operation, hence this request;

WHEREFORE, premises considered, on motion of Kagawad Jose C. Alfaro, Jr., Chairman, Committee on Natural Resources and Environmental Control, severally seconded by Kagawad Claudio P. Larrazabal, Benjamin B. Lladoc, Celso P. Adolfo and Alfredo F. Capahi; be it
