CORIA OF THE DEPARTMENT OF EDUCATION, CULTURE AND SPORTS TO NICLULE IN THE SCHOOL CURRICULUM FOR GRADES 5 AND 6 AND HIGH SCHOOL THE TEACHING OF BASIC ECOLOGY CONSERVATION AND MANAGEMENT STARTING THE SCHOOL YEAR 1993-1997' AND FURTHER TO RECOMMEND TO THE SECRETARY INCLUDE SAID CURRICULA FROM THE PRIMARY LEVEL UP TO THE TERTIARY LEVEL.
