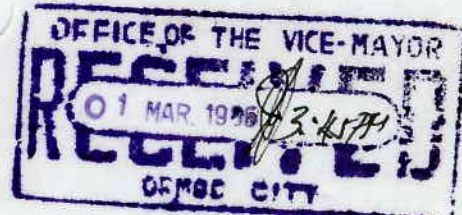

A RESOLUTION APPROVING ORDINANCE NO. 95-002 OF THE
SANGGUNIANG BARANGAY OF BRGY. CAN-ADIENG, ORMOC CITY,
ENTITLED, "AN ORDINANCE PROHIBITING THE RESIDENTS OF
THIS BARANGAY FROM ITS INDESCRIMINATE THROWING OF
GARBAGE, AND/OR UNSANITARY DISPOSAL OF ANY WASTE
MATERIALS, AND PROVIDING PENALTIES THEREOF."

WHEREAS, this august Body is in receipt of Ordinance No. 95-002
from the Barangay Council of Brgy. Can-adieng, this city, entitled, "An
Ordinance prohibiting the residents of this Barangay from its
