RAMOS THRU THE LEADERSHIP OF THE HOUSE OF CONGRESS AND HOUSE OF SENATE FOR RECONSIDERATION OF THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) TO GRANT PRODUCTIVITY INCENTIVE BENEFIT (PIB) TO ELECTIVE OFFICIALS AND RANK AND FILE EMPLOYEES.

WHEREAS, this Sanggunian is in receipt of Resolution No. 004 s. 1996 of the Sangguniang Bayan of Capoocan, Leyte, entitled, "A Resolution respectfully requesting His Excellency President Fidel V.
