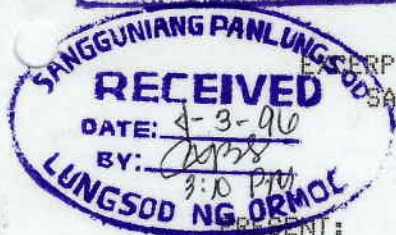

A RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO CHARGE
AGAINST THE ACCOUNT- PROVISION FOR PRIOR YEAR'S
OBLIGATION- A NON-OFFICE ITEM IN THE 1996 ANNUAL BUDGET
THE AGGREGATE AMOUNT OF ₱562,000.00 REPRESENTING
PAYMENT OF THE INCENTIVE ALLOWANCE OF BARANGAY TANODS
FOR THE MONTHS OF NOVEMBER AND DECEMBER, 1996.

PRESENTED for consideration by this august Body is the request of
the Honorable City Mayor for an aggregate sum of ₱562,000.00 to be made
available for payment of the Incentive Allowance of Barangay Tanods for
the months of November and December, 1995;

WHEREAS, the City Budget Officer, through 3rd Indorsement dated 19
March 1996, has recommended that authority be granted to the City
Accountant to charge the said amount of ₱562,000.00 against current
account- Provision Prior Year's Obligation;

WHEREAS, through 5th Indorsement dated 22 March 1996, the DIC-City
Treasurer has stated that funds for the said purpose are available,
