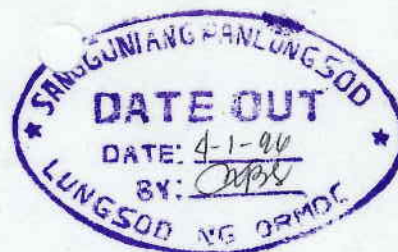

RESOLUTION NO. 96-53

A RESOLUTION REQUESTING THE ORMOC CITY TASK FORCE ON
BUILDING SAFETY COMPLIANCE TO FURNISH A COPY OF THE
REPORT TO THE SANGGUNIANG PANLUNGSOD REGARDING THE
RESULT OF THEIR INSPECTION WITHIN FIFTEEN (15) DAYS
UPON RECEIPT OF THIS RESOLUTION SO AS TO ASSIST THE
SANGGUNIANG PANLUNGSOD IN ITS LEGISLATIVE FUNCTION.

WHEREAS, Executive Order No. 05 s. 1996 entitled, "AN ORDER
CREATING THE ORMOC CITY TASK FORCE ON BUILDING SAFETY COMPLIANCE" was
passed in view of the tragic incident that occurred last March 19, 1996
at OZONE DISCO, Quezon City that claimed the lives of at least 153
persons due to non-compliance and violations of the Building Code and
Fire Safety Code by the owners;

WHEREAS, said Task Force is composed of several officials from
different departments including the Permits & Licensing Division, and
the Building Section of the City Engineer's Office among whose functions
are to inspect buildings/structures to ensure the strict compliance of
the Building Code, and Fire Safety Code; and to see to it that safety
precautionary measures are adopted that to guarantee the safety of the
life and limbs of its occupants;

WHEREAS, to ensure proper legislative action may be made to give
better protection to the community, the City Task Force on Building
Safety Compliance is required to furnish a copy of its report of
inspection to this Sanggunian so as to assist this august Body in its
legislative functions;

NOW, THEREFORE, on motion of Kagawad Jose C. Alfaro, Jr., Chairman, Committee on Police, Fire and Public Safety, jointly seconded by Kagawad Sotero M. Pepito and Benjamin B. Lladoc; be it

RESOLVED, to pass a resolution REQUESTING THE ORMOC CITY TASK FORCE ON BUILDING SAFETY COMPLIANCE TO FURNISH A COPY OF THE REPORT TO THE SANGGUNIANG PANLUNGSOD REGARDING THE RESULT OF THEIR INSPECTION WITHIN FIFTEEN (15) DAYS UPON RECEIPT OF THIS RESOLUTION SO AS TO ASSIST THE SANGGUNIANG PANLUNGSOD IN ITS LEGISLATIVE FUNCTION;
