

A RESOLUTION APPROVING THE APPLICATION FOR PRELIMINARY APPROVAL AND LOCATIONAL CLEARANCE OF SUN VIEW SUBDIVISION, PARTICULARLY LOT NO. 5343 OF THE CADASTRAL ONMOS, OWNED BY CELSO R. MAGNO LOCATED AT BARANGAY BAGONG BUHAY, ORMOC CITY, WITH A TOTAL PROJECT AREA OF 25,519 SQUARE METERS COVERED BY TRANSFER CERTICICATE OF TITLE NO. 28924 CONTAINING SUBDIVISION LOTS, EXCLUDING PARK AND PLAZA, COMMUNITY FACILITIES AND ROAD LOTS.

ESENTED, for consideration by this august Body is the following:

An Application for Preliminary Approval and Locational Clearance of Sun View Subdivision, particularly Lot No. 5343 of the Cadastral Survey of Ormoc owned by Celso R. Magno located at Barangay Bagong Buhay, Ormoc City, with a total project area of 25,519 square meters covered by TCT No. 28924 containing 192 subdivision lots, excluding park and plaza, community facilities and road lots.
