TAN, LOCATED AT BARANGAY SAN PABLO, ORMOC CITY, WITH A TOTAL PROJECT AREA OF 4,008 SQ. METERS COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 28145 CONTAINING TWENTY FOUR (24) SUBDIVISION LOTS EXCLUDING ROAD LOT.
