CODILLAS SR., CITY MAYOR OF ORMOC, TO OPEN COMMERCIAL LETTERS OF CREDIT WITH ANY GOVERNMENT BANK IN FAVOR OF A) SIERRA UNIVERSAL CORPORATION - FOR BASKETBALL PLAYING COURT - \$103,753.80, B) RIMPORT INDUSTRIES - FOR SUPPLY OF SCOREBOARD AND SHOT TIMER - \$18,519.26, C) SIERRA UNIVERSAL CORPORATION - FOR SUPPLY OF PROFESSIONAL BASKETBALL SYSTEM (GOAL) - \$21,572.00, D) SOLANDA ENTERPRISES - FOR SUPPLY OF GENERATOR AND ACCESSORIES AND AUTOMATIC TRANSFER SWITCH (ATS) - \$60,430.00, ALL SAID INSTALLATION AND SUPPLY OF THE NAMED FACILITIES/EQUIPMENT AS MENTIONED IN FOUR (4) UNNUMBERED RESOLUTIONS OF PBAC, WITH THEIR CORRESPONDING AMOUNTS AS CITED, ULTIMATELY FOR THE EARLY COMPLETION OF THE ORMOC COLISEUM.


