RESOLUTION NO. 96-78

A RESOLUTION AUTHORIZING HONORABLE EUFROCINO M. CODILLA, SR., CITY MAYOR OF ORMOC, TO ENTER INTO A NEGOTIATED CONTRACT WITH HI-COOL ENGINEERING CORPORATION FOR THE INSTALLATION OF THE 400 TONS AIRCONDITIONING UNITS WITH COMPLETE ACCESSORIES FOR THE ORMOC COLISEUM IN THE AMOUNT NOT TO EXCEED \$246,800.00 AND \$3,602,400.00 FOR THE INSTALLATION AND LIKEWISE TO OPEN A COMMERCIAL LETTER OF CREDIT WITH ANY GOVERNMENT BANK IN FAVOR OF HI-COOL ENGINEERING CORPORATION FOR THE SUPPLY OF 400 TONS AIRCONDITIONING UNIT WITH COMPLETE ACCESSORIES IN THE AMOUNT NOT TO EXCEED \$246,800.00 SO AS TO AVAIL OF THE TAX EXEMPTION.

WHEREAS, this Sanggunian is in receipt of a letter dated 10 May 1996 from the Honorable City Mayor, the full text of which is hereunder cited as follows:

Gentlemen:

In view of Unnumbered Resolution of the Pre-Qualification Bids and Awards Committee (PBAC), copy of which is hereto attached for your ready reference, may I respectfully request that the undersigned be given authority to enter into a negotiated contract with Hi-Cool Engineering Corporation for the Installation of the 400 Tons Airconditioning Units with Complete Accessories for the Ormoc Coliseum in an amount not to exceed \$246,800.00 for 400 Tons Airconditioning Units with Complete Accessories and P3,602,400.00 for the installation and likewise to open a Commercial Letter of Credit with any government bank in favor of Hi-Cool Engineering Corporation for the Supply of 400 Tons Airconditioning Unit with complete Accessories in an amount not to exceed \$246,800.00 so as to avail of the tax exemption.

Your immediate favorable action on this request is highly appreciated.

WHEREAS, the Pre-Qualification Bids & Awards Committee (PBAC) through said Unnumbered Resolution dated 30 April 1996 mentioned, among others, the following:

a) That there have been three (3) successive failures of bidding for the Supply and Installation of 400 Tons Airconditioning Unit with Complete Accessories for the Ormoc Coliseum, thereby recommending that a negotiated contract be entered into by the City Government of Ormoc with Hi-Cool Engineering Corporation and further authorizing the City Mayor for said purpose per PBAC Resolution dated 15 April 1996.

b) That the said Committee agreed to negotiate for the 400 Tons Airconditioning Units with Complete Accessories including installation in an amount not to exceed, viz:

Installation	-	P3,602,400.00
400 Tons Airconditioning Units with Complete Accessories	-	\$ 246,800.00

c) Considering that said Airconditioning Units with Complete Accessories are to be imported, the Committee also recommended that a Commercial Letter of Credit be opened by the City Government of Ormoc with any government bank in favor of Hi-Cool Engineering Corporation for the supply of the 400 Tons Airconditioning Units in the amount not to exceed \$246,800.00 so as to avail of tax exemption.

WHEREAS, this august Body, through the representation of the Honorable Chairman, Committee on Infrastructures, has considered said request valid and reasonable, hence, must be given due course of action;

RESOLVED, to pass a resolution AUTHORIZING HONORABLE EUFROCINO M. CODILLA, SR., CITY MAYOR OF ORMOC, TO ENTER INTO A NEGOTIATED CONTRACT WITH HI-COOL ENGINEERING CORPORATION FOR THE INSTALLATION OF THE 400 TONS AIRCONDITIONING UNITS WITH COMPLETE ACCESSORIES FOR THE ORMOC COLISEUM IN THE AMOUNT NOT TO EXCEED \$246,800.00 AND \$3,602,400.00 FOR THE INSTALLATION AND LIKEWISE TO OPEN A COMMERCIAL LETTER OF CREDIT WITH ANY GOVERNMENT BANK IN FAVOR OF HI-COOL ENGINEERING CORPORATION FOR THE SUPPLY OF 400 TONS AIRCONDITIONING UNIT WITH COMPLETE ACCESSORIES IN THE AMOUNT NOT TO EXCEED \$246,800.00 SO AS TO AVAIL OF THE TAX EXEMPTION;
